STATEMENT OF POLICY

MTRCB respects the privacy of your personal information. This relates solely to information supplied by you on our websites/mobile app. Any personal information provided by you to the Agency's Website will be used solely for the purpose of providing you with the services you have requested at this website, to update and enhance the Agency's records, to advise you of other services which may be of interest to you. PRIVACY NOTICE FOR INFORMATION COLLECTION AND USE

This Privacy Notice outlines our commitment to collect and process your Personal Data in accordance with applicable laws and regulations on data privacy including the Philippine Data Privacy Act of 2012 (DPA) and its implementing rules and regulations (IRR). In processing your Personal Data, we seek to adhere to the general privacy principles of transparency, legitimate purpose and proportionality, and such relevant principles as required by law

While using our Service, we may ask you to provide us with certain personal information that can be used to contact or identify you, personal information may include, but is not limited to:

LOG DATA
